Chair Adam Grinold called the meeting to order at 10:10 am.

#### Old Business:

Chair asked for a motion to approve October 2019 meeting minutes and December 2019 meeting minutes. Motion moved by Comm. Michael Harrington, second by Scott Giles, approved unanimously by voice vote.

#### 2020 WIOA State Plan (all presentations available <a href="here">here</a>):

Comm. Harrington gave a brief introduction to the Workforce Innovation and Opportunity Act (WIOA) 2020 State Plan, including the purpose of the plan, the vision and goals development in partnership with the Board, and the updated timeline for completion of the plan.

Theresa Hunt (Vermont Department of Labor) gave an overview of WIOA performance measurement, including collection and reporting requirements, performance indicators, negotiation protocols, and recent program performance figures.

James Smith (Division of Vocational Rehabilitation) gave an overview of WIOA Title IV program goals.

Fred Jones (Division for the Blind and Visually Impaired) gave an overview of themes, goals, and priorities for Title IV programs for blind and visually impaired WIOA participants.

Robin Castle (Agency of Education) gave an overview of WIOA Title II programs and explained the role of the Board in reviewing competitive grants for Title II funds.

Tracy Verge and Cindy Robillard (Vermont Department of Labor) gave an overview of WIOA Title I programs, including Adult, Dislocated Worker, Youth, and Rapid Response.

Cameron Wood (Vermont Department of Labor) gave an overview of WIOA Title III programs and services for unemployment insurance claimants.

A public comment period for the plan will be held from March 4-March 18, during which time a draft of the full plan will be available at labor.vermont.gov and vwdb.vermont.gov. A special hearing for Board members will be held on March 17. The final draft of the plan will be submitted to the U.S. Department of Labor on March 31.
