Chair Adam Grinold called the meeting to order at 9:05 am and gave opening remarks.

Commissioner Michael Harrington (Department of Labor) gave brief remarks regarding his transition from Acting Commissioner to Commissioner and the state's response to the influx of unemployment insurance claims as a result of COVID-19.
